## LIABILITY RELEASE FORM

WITNESS THIS RELEASE dated this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_, by and between **Chris or Tammy Blakely**, hereinafter referred to as the Owner or Instructor of Healing Reins Ranch, LLC., Blakely Performance Horses, and \_\_\_\_\_, hereinafter referred to as **Rider**, and, if Rider is a minor, Rider's **parent or guardian**, \_\_\_\_\_.  
For consideration received, and in return for the use, today and on all future dates of the property, facilities and services of Healing Reins Ranch, LLC., Blakely Performance Horses, instructors, employees, drivers and agents; Rider, Rider's heirs, assigns, and representatives, hereby agree as follows:

1. Inherent Risks and Assumption of Risk. The undersigned acknowledges there are inherent risks associated with equine activities such as described below, and hereby expressly assumes all risks associated with participating in such activities. ***The inherent risks include, but are not limited to the propensity of equines to behave in ways such as, running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in an injury, harm or death to persons on or around them; the unpredictability of equine's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals; certain hazards such as surface and subsurface conditions; collisions with other animals; the limited availability of emergency medical care; and the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within such participant's ability.***

Rider acknowledges that horses, by their very nature are unpredictable and subject to animal whim. Rider assumes all risks in connection therewith, and expressly waives any claims for any injury or loss arising therefrom. Rider agrees to abide by and follow Manager's rules and regulations which, shall be posted and/or available from time to time. Rider further acknowledges that the behavior of any animal is contingent to some extent upon the ability of Rider. Rider assumes all risks therefor and warrants a full and fair disclosure of Rider's abilities has been made to Manager.

Rider expressly releases the Owners or Instructor of Healing Reins Ranch, LLC., Blakely Performance Horses, from any and all claims for personal injury or property damage, even if caused by negligence (if allowed by the laws of this State) by the Owners or Instructor of Healing Reins Ranch, LLC., Blakely Performance Horses, or its representatives, agents or employees.

### **WARNING**

***Under Oklahoma law, a livestock activity sponsor, a participant or a livestock professional acting in good faith and pursuant to the standards of the livestock industry shall not be liable for injuries to any person engaged in livestock activities when such injuries result from the inherent risks of livestock activities, pursuant to the Oklahoma Livestock Activities Liability Limitation Act, Okla. Stat. tit.76 §50.3 (2001).***

2. Rider agrees to assume any and all risks involved in or arising out of Rider's use of any equipment or livestock pertaining to horses or taking of riding lessons, the use of premises of Healing Reins Ranch, LLC., Blakely Performance Horses, and for purposes of taking riding lessons either on the premises or lessons given off the premises of the Owners or Instructor Healing Reins Ranch, LLC., Blakely Performance Horses.

RIDER (OR RIDER'S PARENT OR GUARDIAN IF RIDER IS A MINOR) AGREES TO HOLD HARMLESS, INDEMNIFY AND THE OWNER OR INSTRUCTOR OF HEALING REINS RANCH, LLC., BLAKELY PERFORMANCE HORSES, AGAINST ANY AND ALL CLAIMS, DEMANDS, CAUSES OF ACTION, DAMAGES, JUDGMENTS, ORDERS, COSTS OR EXPENSES, INCLUDING ATTORNEY'S FEES, WHICH MAY IN ANY WAY ARISE FROM OR BE IN ANY WAY CONNECTED WITH RIDER'S USE OF OR PRESENCE UPON THE PROPERTY OF OWNER OR INSTRUCTOR OF HEALING REINS RANCH, LLC., BLAKELY PERFORMANCE HORSES, AND THE FACILITIES LOCATED THEREON. In the event Rider is a minor, the parent or guardian shall further indemnify, defend and hold Owners or Instructor of Healing Reins Ranch, LLC., Blakely Performance Horses, harmless from any such claims by said minor child.

4. In the event Rider is using Rider's own horse, or a horse(s) not owned by Healing Reins Ranch, LLC., Blakely Performance Horses, Rider warrants said horse(s) shall be free from infection, contagious or transmittable diseases. Owners or Instructor of Healing Reins Ranch, LLC., Blakely Performance Horses, reserves the right to refuse access or use of any horse upon the premises that does not appear to Healing Reins Ranch, LLC., Blakely Performance Horses, to be in good health, or is deemed dangerous or undesirable.

6. Rider agrees to waive the protection of any applicable statutes in this jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing said release.
